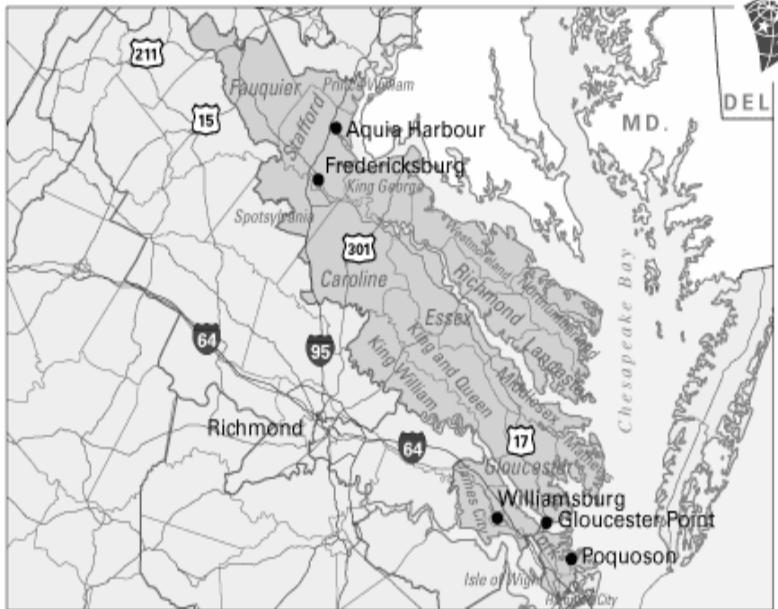

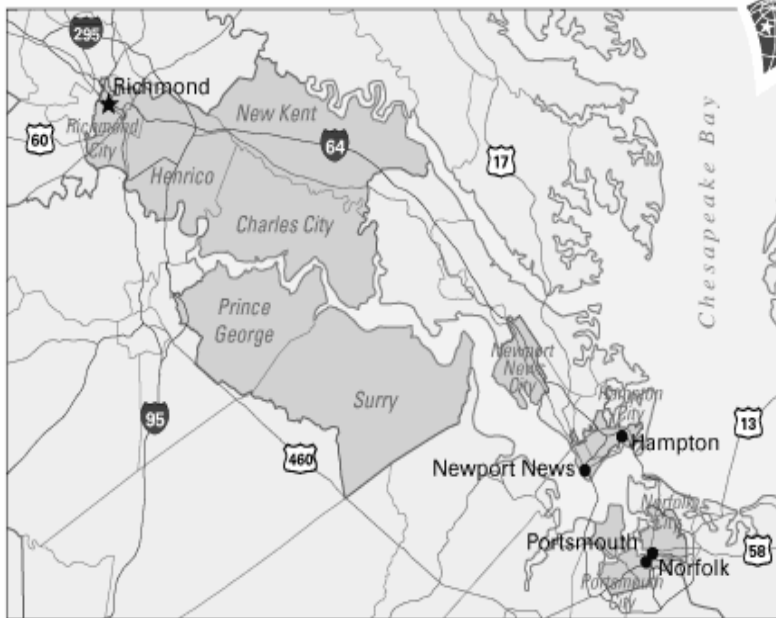

Sessions last 60 days in even-numbered years and 30 days in odd-numbered years with an option to extend any regular session for not more than 45 days. The General Assembly is a bicameral legislature with a 40 member Senate and a 100 member House of Delegates.

General Voting Information for Virginians

Anyone who is a citizen of the United States, resides in Virginia, is not a convicted felon, has not been judged mentally incapacitated, and will be 18 years old on or before the general election may register and vote.

To register, you must give your Social Security number, full name, sex, date of birth, present residence address, and place of previous registration. You may register to vote at your Voter Registrar's office, by mail, at the Department of Motor Vehicles, or at any special registration site. When you move, you must register and then vote in your new locality.

Voter registration books close 22 days prior to a primary or general election.

General elections are held every November. Polls are open 6:00 AM to 7:00 PM. For more information, including the process for restoring the right to vote to those convicted of a felony, contact the Virginia State Board of Elections at www.sbe.virginia.gov or 804-864-8901 (toll free 800-552-9745).
